## INTRODUCTION To the annual plan

Our freshwater taonga continue to face ongoing and increasing pressure, including declining water quality, habitat modification and loss, barriers to fish passage and migration and a changing climate. These factors give rise to serious concern for the health, wellbeing and abundance of our freshwater taonga.

The Trust's core values are:

- Te Mana o Te Wai, reflecting that freshwater ecosystems come first.
- Whakapapa, reflecting the connection between whānau, hapū and iwi, and te taiao.
- Kaitiakitanga, reflecting whānau, hapū and iwi obligations, as descendants of ngā Atua.

These values determine the way we approach our work and define the way we behave. These values involve us moving from talk to action, to strategise and mobilise, and to put the interests of freshwater taonga first.

Ensuring the health and wellbeing of freshwater is essential for the continued health and wellbeing of freshwater fisheries. Healthy freshwater fisheries require good management of freshwater habitat and the wider environment. Many of the pressures on our freshwater taonga are due to modification of freshwater environments.

There is a need to identify and articulate iwi and hapū values in relation to freshwater species and ecosystems to improve awareness in resource management processes, and influence agencies with responsibilities for freshwater fish and habitat.

# 2021/22 **PRIORITIES**

Our key priorities for 2021/2022 include the following programmes and projects:

#### **RESPONDING TO LEGISLATIVE REFORM AND POLICY**

- Providing continued support to the Freshwater Iwi Leaders Group in seeking to ensure that the rangatiratanga of iwi and hapū guaranteed under Te Tiriti o Waitangi is upheld in the Government's ongoing resource management reform and freshwater review processes. This includes:

  - - Three Waters reform
- Wider legislative reform included in this work programme includes biodiversity and climate change.
- In partnership with iwi and hapū, Te Wai Māori will develop policy responses and other initiatives to key legislative reform affecting freshwater taonga.

#### **INDIGENOUS FRESHWATER SPECIES**

• The Trust will continue to support species specific work programmes and initiatives including continued work on Tuna, Piharau/Kanakana and Inanga.

#### **TARGETED RESEARCH**

• Support research on indigenous freshwater species and research projects with a focus on kaupapa Māori approaches to assessing and monitoring freshwater health.

#### ENHANCE THE RECOGNITION AND STATUS OF **INDIGENOUS SPECIES**

- Raise awareness of pressures facing our freshwater taonga
- Build strategic relationships and influence policy outcomes to . ensure freshwater taonga are considered and provided for.
- Assist iwi and hapū to articulate their values and aspirations . and enhance their relationship with freshwater taonga.

- Seek to ensure that the rangatiratanga of iwi and hapū guaranteed under Te Tiriti o Waitangi is upheld in the Department of Conservation's whitebait management review. This includes seeking to ensure that the relationship of Māori with traditional waters and fisheries are given appropriate recognition and that customary fishing rights are upheld.
- Seek to ensure that to Department of Conservation's whitebait management review addresses the wide range of threats facing the species including habitat loss and degradation, fish passage barriers, water quality degradation, climate change and predation by introduced species.
- Tuna:
  - The Trust will continue to contribute to the national review for longfin tuna, engaging with tangata whenua, and those

- Improve knowledge of Piharau/Kanakana by identifying, supporting, and distributing research.
- Build strategic relationships with relevant agencies to enhance the health and wellbeing of Piharau/Kanakana and work with those agencies to improve the ability of iwi and hapu to influence decision making for the species and its habitat.
- Raise awareness and education of Piharau/Kanakana as a taonga.





#### **KEY ASSUMPTIONS**

Key assumptions in constructing the budget are basing Te Wai Māori income on the following:

- Annual drawdowns for operational expenditure are targeted to be no more than 4% of the average of the previous 3 years of the total portfolio investment fund attributable to Te Wai Māori.
- Transition to the diversified portfolio agreed under the Statement of Investment Objectives and Policies (SIPO) and review of SIPO completed to ensure it continues to be appropriate for the organisation's requirements and investment climate.
- Short term funds held outside of the portfolio are managed to maximise returns, within acceptable risk parameters, for the period they are held.
- Available cash flows are managed to meet the needs of Te Wai Māori.
- The returns from the portfolio are monitored to ensure the planned expenditure is aligned with the prospective available returns.
- Surplus investment income, above the 4% available for annual drawdowns, is transferred into a capital maintenance reserve to preserve the real value of the portfolio and therefore income available for operational expenditure.
